December, 2019


## The Village office will be closed for the following holidays:

## Winter Reminders:

The winter parking ordinance is in effect. This ordinance prohibits parking on Village streets between the hours of 2:45 a.m. and 7:00 a.m. You may not park overnight on the street even if there is no snow. Village parking lots are available for overnight parking of vehicles.

(5) SNOW AND ICE REMOVAL Ordinance 2019-7 (Repealing Recreating Section 30-5 (a) & (b) of the Municipal Code)

- (a) Sidewalk, Crosswalk and Handicap Accessibility Ramps to be Kept Clear. The owner, occupant or person in charge of any parcel or lot which fronts upon or abuts any sidewalk, shall keep said sidewalk clear of all snow and ice. In the event of snow accumulating on said sidewalk due to natural means and/or by any other means, said sidewalks shall be cleared of all accumulated snow and/or ice within 24 hours from the time the snow ceases to accumulate on said sidewalk. Sidewalks are to be kept clear of snow and ice for the width of the sidewalk. In the event that ice has formed on any sidewalk in such manner that it cannot be removed, the owner occupant or person in charge of the parcel or lot which fronts upon or adjoins said sidewalk shall keep the sidewalk sprinkled with material to accelerate melting or prevent slipping.
  - (b) **Deposit in or Across any Street Prohibited**. No person shall deposit, or cause to be deposited, any snow or ice taken and removed from his/her premise or elsewhere upon any sidewalk, alley, parkway, public place in or across any street in the village. Snow shall not be piled at or near intersections so as to obstruct the view of pedestrians or operators of motor vehicles.

Fourth Quarter Water Bill – Due January 17. Please do not include payment of your water bill on the same check as your tax payment. The tax and water bills are two separate departments. Water bills should be made payable to the Random Lake Water Department and tax payments payable to Village of Random Lake. Please feel free to use the drop box after hours and we will pick it up on the next business day.

## Why a Sewer Rate Increase: From the Desk of the Village President

The existing waste water treatment plant is 45 years old. The life expectancy is 20 years. We definitely have been serviced well because of the proper design and appropriate maintenance. For the last 5 plus years the Village has been exploring the need for updates and for a new Waste Water Treatment Plant.

Either option requires the need to increase the existing sewer rate. The Village Board approved to raise the present rate by 9% per 1000 gallons used. That will allow the Village to line, repair, or replace the present sewer in certain areas, some of which were installed in 1936. It is beyond time to address these issues. In 2021, with final design of the WWTP, we will again examine the sewer expenses and address the rate issue. By keeping on top of the rate schedule, we will be able to meet the costs associated with the WWTP infrastructure without borrowing 100% of all costs. That in itself will be a savings to the residents. No one on the board wants to raise rates, however, the board as your elected representatives, unanimously saw the need to do so. I applaud the Board in its decision; I believe their vote had the best interest of the Village, its residents, & the future in mind. If you have any questions, feel free to call me. ## DOG and CAT licenses are required in the Village of Random Lake.

### Licenses can be purchased from the Village office located at: 96 Russell Drive

Wisconsin Statutes (Sections 95.21(2), 174.05, and 174.07(1) (b)) require all dogs that are 5 (five) months of age or older to be licensed. The owner of the dog must obtain a license annually prior to April 1<sup>st</sup>, OR, on or before the date the dog becomes 5 (five) months of age. \*Evidence that the dog/cat is currently immunized against rabies must be

presented before a license can be issued. Failure to obtain a license prior to the April 1<sup>st</sup> deadline will result in a late fee of \$10.00 per animal. A dog/cat license may NOT be transferred from one dog/cat to another.
