## Tax Collections-2020

Personal Property Tax: Paid in full by January 31st of each year.

Real Estate Tax: First installment due by January 31st: Payable to the Village of Random Lake

- Second installment due by July 31st: paid directly to the Sheboygan County Treasurer. 508 New York Avenue, Sheboygan, WI 53081-4126.
Taxes are collected in December and January at the Village Office during regular business hours. The office will be closed December 24, 25, 31 and January 1. Due to COVID-19, we are highly encouraging the use of the drobox outside the main entrance of the Village Hall or payments by Mail.
- If you are not paying in person and would like a receipt, you will need to include a selfaddressed stamped envelope.
- To receive credit for payment in 2020, envelopes must be postmarked by December 31.

2021 Spring Election:

- April 6th, 2021

The spring election will have 3 two-year term Trustee positions on the ballot.

Also on the ballot is the office of Village President, currently held by Interim President Mike San Felippo.

Nominations papers must contain the signatures and addresses of at least 20 Village residents \& be filed at the Village Office prior to 5:00 p.m. Tuesday, January 5th, 2021.

## VILLAGE REMINDERS:

- If you would like to connect virtually to the Board Meeting, but need help, please contact the Village Office M-F 8-4pm for assistance.
- Winter Parking is in effect as of the first measurable snowfall. There is no parking on Village streets between the hours of 2:45 a.m. \& 7:00 a.m.
- Sidewalks need to be cleared of ice/snow within 24 hours from the time the snow ceases.
- Snow is prohibited from being placed in the road. Also, snow shall not be piled at or near intersections to obstruct the view of pedestrians or operators of motor vehicles.
- Village crews will be picking up Christmas Trees and wreaths put out by the curb. Please remove all lights, tinsel, and other decorations from your trees and wreaths, or they will not be picked up. Please no artificial trees.
- Dog and Cat Licenses are required in the Village of Random Lake. All dogs that are 5 months of age or older are required by WI state statute to be licensed. Licenses can be purchased at the Village Office. Proof of current rabies vaccine is required. Failure to obtain a license by March 31st will result in a late fee of $\$ 10.00$ per animal. Brush Pile is closed until Spring
